Bill,

If you read my email then you seem to have missed an opportunity to understand how a huge organization works. I tried to explain it so you could improve your efforts to get through to us when you wish to. Obviously that seems to have failed. I can only tell you that similar approaches will end up with the same results.

Tom Burr may or may not be working with the Nelson Mandela Park project manager. If so and he had a concern he should have raised it directly with the project manager. We are not involved in working on the rest of the Regent Park project in so far as having responsibility for work being done. I would suggest you talk to the Daniel Corporation about issues involving Regent Park building and excavation etc. We are responsible for TDSB work and we are legally liable for all of it. If there are problems, a meeting can be arranged quickly with us. As for coordination between the two organizations, we each are responsible for our own projects and if coordination is needed, and I am sure it is from time to time, then it will be arranged between officials from the two agencies but would not be part of a public meeting.

I'm not sure where the implication that TDSB does not meet outside normal business hours comes from - half my life at least involves meetings outside of normal business hours, as it does for many staff as well. Staff are entitled to a home life and to be able to go home to be with their families but when a meeting is needed and can't be accommodated in business hours then it happens after hours. This is not a preferred approach as I am sure you can well understand.

As for meetings with residents, the issues I have seen referred to in this string of emails do not require a public meeting involving the TDSB. They can be raised through an email or a phone call, addressed by staff, and resolved.

If members of the public want to get together for any purpose that is certainly their right and I would not dream of interfering in it. My concern is the TDSB and how we manage very scarce staff resources and how we manage our time and resources to best meet the needs of our students.

Because of that, I doubt very much if there will be any TDSB people at the June meeting. June is an exceedingly busy month for staff and many will already be putting in excessive hours at end-of-the-year school functions. There is no need for a public meeting when more

effective and efficient ways exist to resolve concerns.

Also, there is no need to wait until June to have a meeting. Why would we let these concerns go on for another three months when we could deal with them now? A public meeting takes time to set up. We could arrange a half hour meeting with 3 or 4 residents to outline the concerns, then we could get at resolving them quickly. This could be done over the next two to three weeks, long before June rolls around.

I hope this further clarification helps.

- the implication that TDSB "doesn't like meetings outside of normal business hours" isn't acceptable; the entire point of the meeting, which may not be understood by TDSB is "meet with **residents**, and hear directly any **residents'** concerns" (instead of having a private meeting between TCHC and TDSB, as suggested)

Hi Annely,

There are two specific problems with the email sent below.

First, any email that has that number of recipients usually ends up in my round file, as it does in most tdsb mail boxes. We receive hundreds of emails a day and I only respond directly to those that are addressed to me or are part of a small, manageable group of which I am a member. We receive emails from everyone imaginable, from vendors, to parents taking a concern about their child public when it should be (and will only be) dealt with locally, from fundraisers, from people seeking to sell materials to the tdsb, from students in college trying to get us to take on their homework assignments - the list is endless. I don't get into any of these concerns because it isn't my specific business and I have no time to deal with them. If my day is really busy and I open an email that has more than 20 recipients, I immediately close it and either pitch it or come back to it days later when I have time.

Secondly, Baila, Dane and Gary are principals of other schools in Ward 14 and they have nothing to do with matters at Nelson Mandela Park. They would ignore the email because it is not their business. I assume the nicole in the address could have been Nicole Pearson but since that email would not have been delivered as addressed (there being no such person as nicole) she would not have received it. Jody Burton also is not directly involved in Nelson Mandela concerns and she most likely would not have paid any attention to the email. All of the people listed have no responsibility or authority for Nelson Mandela Park

PS and they would assume that the people who do have responsibility would have been invited and would be dealing with it. And they would not take any further action because they are stretched to the limit dealing with their own immediate responsibilities.

There is an additional item and that is **that time is not easily available for these kinds of meetings**. If there is a specific issue, such as those you outlined, then the fastest way to reach resolution is for you to ask for a meeting with 2 or 3 of you with a couple of people from the tdsb, who can initiate the action needed to solve the problems. A personal email to me directly would have received an answer within 24 hours and we would have already met by now and have scheduled changes to meet your concerns.

I have taken the time to get into our process in the hope that it will make it much easier in the future for you to get a response to an issue you are concerned about.

I know Melanie and/or Mika will be in touch with you early next week and we will make sure we address your concerns as they relate to us.

Hi to you both,

That explains why we weren't there. We have looked high and low through various staff members, including the principal, the superintendent, my assistants, myself, planning staff, and facilities staff and there is no record anywhere of anyone being invited to a meeting about the construction site around Nelson Mandela Park PS.

I'm afraid a verbal invitation to someone on the construction site or even to the architect is not an invitation to the TDSB and explains why no one from the TDSB responded.

However, now that I am aware of the concerns, I would suggest that rather than a public meeting, it would be much more efficient and much more focused if my assistants met with you - you decide which would be better: one of you, both of you, or a designate - to let us know the specific concerns and to go over them with you with a view to arriving at solutions.

I am in the middle of a changeover in my staff so it is likely both of them will meet with you. Melanie Dickstein will be leaving my office at the end of March and Mika Bishop joined my office February 15. I believe we can quickly deal with problems relating to Nelson Mandela Park PS construction work once the two of them meet with you.

I have copied also our superintendent and our principal and I will ensure that facilities staff will be involved as appropriate, following Melanie and Mika meeting with you.

I'm sorry we were not present but, as I said, it was impossible for us to attend a meeting we knew nothing about. We will move quickly now to mitigate the problem.

**Although TDSB was invited to last night's meeting; I was very disappointed that TDSB didn't attend, or offer any reasons for not attending.**

Trucks exiting the school construction site (using street access immediately west of the Nelson Mandela Park Public School building) track large amounts of dirt onto Shuter Street, in both directions. This uncontrolled dirt from the school site clogs the roadway and is not being cleaned away from the eastbound curb lane of Shuter Street, for months at a time. This has been an ongoing problem for several months, in spite of complaints from many residents.

Shuter Street residents are hopeful that TDSB will be more sensitive and responsive to complaints

about the negative impacts on the surrounding neighbourhood, of the school reconstruction activities.

The recently formed Regent Park Community Construction Liaison Committee is an excellent opportunity for both TDSB and TCHC to hear concerns from the neighbourhood. Both the school re-construction activities as well as Regent Park rebuilding, are causing disruption/inconvenience to local residents.

As our elected representative, I hope you can ensure that TDSB is represented at the next meeting.
